A RESOLUTION INITIATING PROCEEDINGS TO ANNEX CERTAIN PROPERTY TO THE TOWN OF ALPINE AND ESTABLISHING A DATE, TIME AND PLACE WHEN A PUBLIC HEARING WILL HELD CONCERNING SUCH ANNEXATON AND PROVIDING FOR PUBLISHING AND MAILING NOTICE OF SAID HEARING.

WHEREAS, the Town Council for the Town of Alpine, Wyoming, pursuant to Wyoming Statute \$15-1-404 has initiated proceedings to annex certain territories located adjacent to and contiguous with the corporate limits of the Town of Alpine, said property being located within the SE1/4 of Section 30 and the SW1/4SW1/4 of Section 29, T37N R118W, Lincoln County, Wyoming, said parcel more particularly described on Exhibit A attached hereto and made a part hereof by this reference; and

WHEREAS, the Town Council for the Town of Alpine, Wyoming has reasonable evidence that the area to be annexed meets the conditions and limitations set forth in Wyoming Statute §15-1-402; and

WHEREAS, the Town Council has caused to be prepared a legal description and map of the area considered for annexation, which is attached to this resolution as Exhibit A;

NOW, THEREFORE, BE IT RESOLVED, by the Town Council of the Town of Alpine that it has reasonable evidence that the foregoing described property complies with the conditions and limitations of Wyoming Statute §15-1-402;

BE IT FURTHER RESOLVED THAT, on the \_\_\_\_\_ day of \_\_\_\_\_\_, 2007, at \_\_\_\_\_ p.m., a date not more than thirty (30) days nor more than one hundred twenty (120) days after the effective date of this resolution, a public hearing will be held for the purpose of determining whether the proposed annexation complies with Wyoming Statute §15-1-402; and

BE IT FURTHER RESOLVED THAT, that the Town Clerk is hereby authorized and directed to cause a notice of the time and place of said hearing to be published twice in the Star Valley Independent at least thirty (30) days prior to the hearing; and it is further directed to prepare a proposed annexation report pursuant to Wyoming Statute §15-1-402(c) and send by certified mail a copy of such proposed annexation report to all landowners and affected public utilities located within the area to be annexed at the address used to mail county property tax notices, and shall notify all such landowners and affected public utilities the time, date and location of the public hearing.
